Terms of direct cremation:

The body is transferred to the funeral home from within 25 miles, placed in refrigeration until the necessary **AUTHORIZATIONS** and permits are obtained, placed in a cardboard cremation container required by the crematory and delivered to the crematory. The body is cremated and the cremains are then returned to the funeral home for return to the family. There is no public viewing, rites or ceremony. Crematory fees are included in the prices shown above and will be deducted if already prepaid elsewhere.
